**Conclusion/Summary**: Low acute inhalation toxicity. As with exposure to high concentrations of any dust,

minimal irritation of the respiratory tract may occur. Pure titanium dioxide, a minor component of this product, has been listed by IARC as a group 2B (possible carcinogen). This classification is based on rat "lung particulate overload" studies performed with airborne particulate. Toner is not listed by IARC, NTP, or OSHA. Long term exposure to excessive concentrations of iron oxide-containing dusts has resulted in a condition identified as siderosis, a relatively benign pneumoconiosis, caused by deposition of iron oxide particles in the lung.
